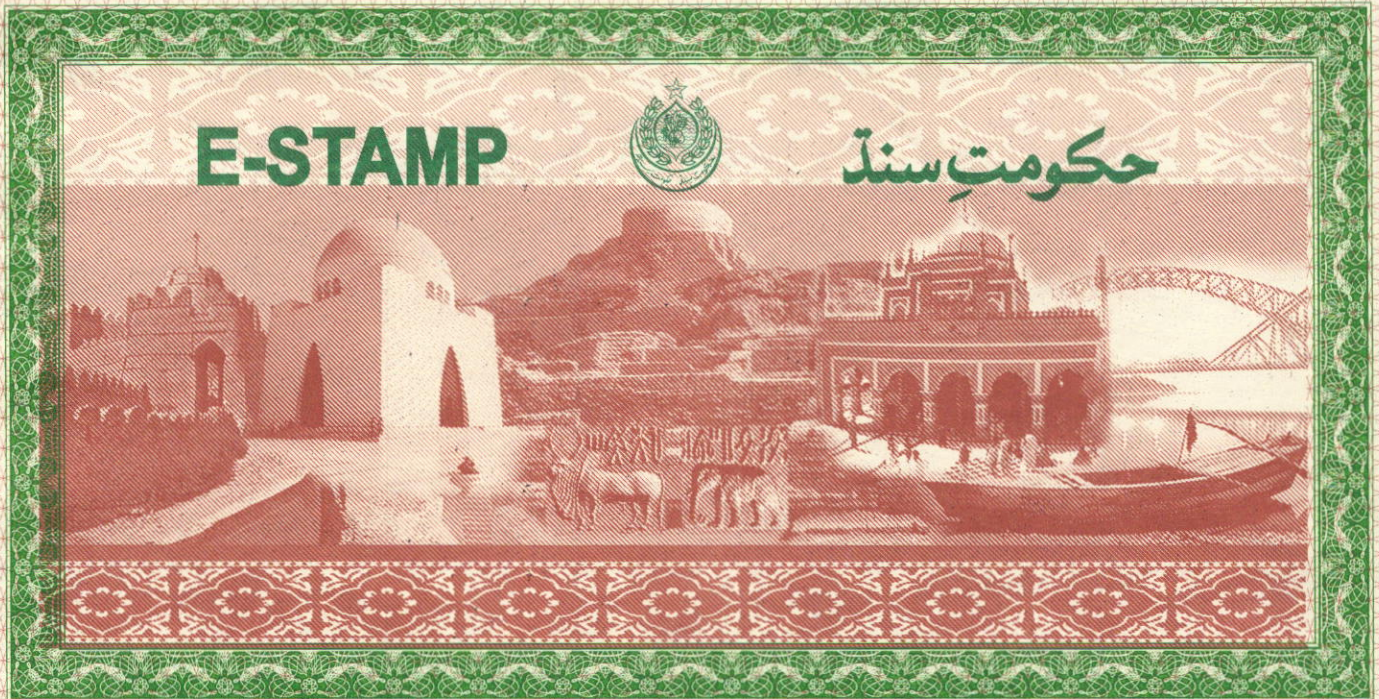

BETWEEN

Tariq & Brothers, acting through its **Proprietor** having its office located at **Plot # 428, Near Noor Subhani Masjid, Natha Street, Nishtar Road, Karachi**, who is fully authorized in this behalf hereinafter referred as Service Provider (which expression, wherever the context so required, shall include its heirs, executors, assigns, and administrators as the case may be) of The Second Part.

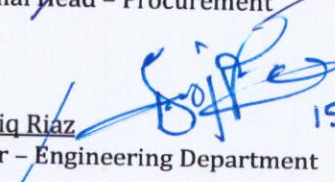
**317-SUPPLY OF SWEET WATER AT VARIOUS PREMISES OF STATE BANK OF PAKISTAN

SIGN OF CONTRACT AGREEMENT**

1. Case for award of contract, having ICM case no. 1149673 was approved by Managing Director on 18-May-26 and sanctioned the expenditures under ER-19. Subsequently, the acceptance letter for the subject contract was issued on 03-Jun-26 to the most advantageous bidder i.e., M/s M.S. Tariq & Brothers at their quoted rates of Rs.3,260 per 1000 gallons.
