1 PERFORMANCE/WARRANTY BOND GUARANTEE

The Performance / Warranty Bond Guarantee, if provided within the given time of 30 days, shall remain valid for a period of not less than 6 months, after the last portion of the goods and / or services have been delivered to the final destination indicated in the contract. In case Performance/Warranty Bond Guarantee is not received within given time of 30 days, the validity period of 06 months will be increased to 09 months after the last portion of the goods and services are delivered to final destination, in case, Performance/Warranty Bond Guarantee is not received within 60 days, the relevant clauses of the tender / purchase order will be invoked, contract with terminated and submitted bid bond will be forfeited.

2 Material should be supplied as per technical specifications mentioned in the quotation/purchase order and must be brand new. Sub-standard / defective and re-conditioned material will have to be replaced by you on "NO CHARGE BASIS" even after our acceptance.

3 Please mention your National Tax Number on the invoices to be submitted for payment.

4 DELIVERY

Delivery of above material will be made by you within **30 days** after receipt of purchase order at our SNGPL Store, 21-Kashmir Road, Lahore, under intimation to us.

5 You are required to provide valid Professional Tax Clearance Certificate for the current year.

6 SALES TAX

The above price is inclusive of all Govt. Taxes / Duties Including Sales Tax @ 18%. However, the payment of Sales Tax will be made to you on submission of Sales Tax invoices. We as per Sales Tax Special Procedure (withholding) Rules 2007, shall deduct an amount equal to 1/5th of the total sales tax value shown in the sales tax invoice issued by the supplier and make payment of the balance amount.

"Sales Tax return of the relevant bill along with all related documents should be submitted with the invoice(s)"

7 PAYMENT

Payment will be made to you by our Account Department within 30 days after satisfactory completion of delivery as given in the purchase order and after receipt of your bills duly marked your National Tax Number in duplicate supported with receipted copies of Delivery Challan and copy of inspection reports.

8 LATE DELIVERY CHARGES

i If the material as given in the order have not been dispatched/delivered as per stipulations in the contract except on account of Force Majeure within the delivery period given in the contract, Sui Northern Gas Pipelines Limited shall be entitled to recover 1% (one percent) of the total value of the contract price (excluding sales tax) of the delayed part of material for each week of delay by way of Late Delivery and not by way of penalty subject to maximum of 10% of the total value of the delayed part of the material.

ii The payment of such Late Delivery shall not relieve the supplier from performing and fulfilling its obligations under the contract nor will the corresponding rights and entitlements of Sui Northern be affected or reduced in any manner.

iii Whenever Late Delivery become payable, Sui Northern Gas Pipelines Limited, shall quantify the same and serve a written notice upon the supplier requiring immediate payment thereof. If the supplier fails to remit payment within 15 days of receipt of such notice served under registered postal cover, Sui Northern will become entitled to recover the same forthwith by calling upon the Performance/Warranty Bond Guarantee. Any withdrawals by the way of Late Delivery out of the Performance/Warranty Bond Guarantee will be made good by the supplier within 60 days of receipt for the above referred notice by way of amendment to the Performance/Warranty Bond Guarantee failing which the remaining portion of this Guarantee would become encashable in favour of the Buyer on account of any such failure.

9 All other terms and condition of the tender enquiry and those which have been agreed to through exchange of correspondence after bid opening are integral part of this contract.

10 Manufacturing date of tyre within one year at the time of delivery.
