CONTRACT AGREEMENT

OPERATION & MANAGEMENT (O&M) OF ALLIED SERVICES i.e. SECURITY/WATCH & WARD SERVICES & PATROL VEHICLES & MOTORBIKES etc ON LYARI EXPRESSWAY TILL 30.06.2027

THIS CONTRACT AGREEMENT made on the 6th July of 2026 between **National Highway Authority, "Employer"** 28- Mauve Arca G-9/1 Islamabad and M/s SSS Corporation 116-C, 4th Floor, Al-Murtaza Commercial Line-03, Main Khayaban-c-Iqbal, Phase Viii, DHA, Karachi.

WHEREAS the Employer following the due procurement process, has accepted the OMC's bid of **Rs. 2,945,760/-** per month and **Rs.1,000,000** as provisional sum to be paid to the OMC. The contract is for the period ending 30th June, 2027, irrespective of its date of commencement. The Contract is for O&M of Allied services by OMC at Lyari Expressway strictly in line with the requirement of Employer as set out in the contract documents.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
