This Contract for Vehicle Sales (hereinafter called the “Contract”) is made the 24th day of the month of July, 2026, by and between

and

Mr. Umar Sajjad, having its registered office (address) at House No 23, Street No 28, F-6/1 Islamabad (hereinafter called “Buyer”) which expression wherever the context so permits shall mean and include its successors-in-interest and permitted assigns, on the other part.

Both Seller and Buyer may be collectively referred to hereinafter as the “Parties” and individually as the “Party”.

WHEREAS:

1. Seller invited bids for auction of vehicles vide press advertisement no. 10367/25 dated June 28, 2026;
2. Seller participated in the auction of vehicles as described herein and turned out to be highest bidder;
3. Buyer, being successful bidder, has agreed and warranted to Seller that it shall buy the vehicle in accordance with the terms and conditions set forth hereinafter and included in the bidding document.

NOW THEREFORE, in consideration of the mutual covenants and agreements the Parties hereto enter into this Contract on the following terms and conditions:
