2. Strict supervision should be carried out to ensure the quality of work & material.
3. It should be ensured that the civil work is carried out as per IESCO SDI.
4. The expenditure should be restricted to sanction amount/budget allocation.
5. Variation in the estimated cost due to right of way problem/rate escalation in cost of civil work during construction work or any other reason should be intimated to concerned office for approval from competent authority well in time. The material of said work must be drawn from store without delay if escalation of cost involved in material the concern official / officer will be held responsible for such delay.
6. All Standard Design Instruction/standing polices, should be strictly followed according to the latest instructions of IESCO.
7. The progress on the work be communicated to this office on monthly basis.
8. The performance of concerned contractor should be intimated accordingly, if any complaint against contractor regarding quality / delay during the execution of work must be communicated to this office.
9. All terms & conditions as per SOP should be clearly mentioned in the agreement form to be signed between contractor and concerned Construction Division.
