 - ii) **M/s. Global Source Int, Karachi** hereinafter referred as supplier, which expression shall, unless repugnant to the context of meaning thereof, be deemed to include its successors and permitted assigns of the OTHER PART.


NOW THEREFORE PARTIES HEREBY AGREE AS FOLLOWS

The no appeal or review will be permissible against the decision of inspection committee.
- iii) That the office of the **Director, FIA, Karachi Zone**, shall give written receipt signed giving out complete details, exhibiting the number of items/articles delivered and the number items/articles accepted and rejected, and such receipts shall be conclusive evidence of the acceptance and rejection of the number of articles specified as accepted and rejected.
- iv) That all articles accepted shall be paid by office of the **Director, FIA, Karachi Zone, Karachi** to the supplier at the rate specified in the bidding documents/work order on FOR basis within the financial year 2025-26.

8. Any notice required under this contract agreement shall be in writing and shall be effective when received by the addressee at its given address.

If any term, conditions, or provision in this Agreement is found to be invalid, unlawful or unenforceable to any extent, the parties shall endeavour in good faith to agree to such amendments that will preserve, as far as possible, the intentions expressed in the Agreement. If the parties fail to agree on such amendments, such invalid terms, condition or provision will be served from remaining terms, conditions and provisions, which will continue to be valid and enforceable to the fullest extent permitted by law.
9. This agreement may be amended only in writing signed by both the parties.
