Khan Road, Karachi,** hereinafter referred as Purchaser, which expression shall unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns officers delegated to perform functions procurements for and on behalf of various units of Sindh Police department of ONE PART.

  - ii) **M/s. Athar Construction & Sons, Karachi** hereinafter referred as Contractor/Supplier, which expression shall, unless repugnant to the context of meaning thereof, be deemed to include its successors and permitted assigns of the OTHER PART.
2. WHEREAS the Director, FIA Karachi Sindh is entrusted with responsibility of procurement of item / articles during current financial year 2025-2026 as per description, with specification and quantity mentioned in the bidding documents.
4. That **M/s. Athar Construction & Sons** participated in the response of open tenders for **repair of furniture & fixture EPADS Ref No: P28181**, floated by the Director, FIA Karachi Zone, Karachi by submitting bid, after necessary evaluation of the item / articles described above; the Procurement Committee opened the financial bids in front of all bidders on 14-05-2026.

**NOW THEREFORE PARTIES HEREBY AGREE AS FOLLOWS**

- i) **M/s. Athar Construction & Sons** shall complete the work i.e. repair of furniture & fixture, described and specified along with quantity the above within \_\_\_\_ days from the date of signing of this agreement.
- ii) That the repair work shall be done and finished in all respects to entire satisfaction of Inspection Committee which shall be at liberty to reject any item/article or part thereof if it is not in accordance with approved specification mentioned in the tender documents submitted by contractor/supplier at the time of bidding, and evaluated and approved for this purchase / work order and such rejection shall be final. The no appeal or review will be permissible against the decision of inspection committee.
- iii) That the **office of the Director, FIA, Karachi Zone, Karachi** shall give written receipt signed giving out complete details, exhibiting the number of items/articles repaired and the number items/articles accepted and rejected, and such receipts shall be conclusive evidence of the acceptance and rejection of the number of articles specified as accepted and rejected.
- iv) That all articles accepted shall be paid by **office of the Director, FIA, Karachi Zone, Karachi** to the supplier at the rate specified in the bidding documents/work order on FOR basis within the financial year 2025-26.

- v) In case **M/s. Athar Construction & Sons** make default, in the due performance of this agreement/contract in part or full, **Director, FIA Karachi Zone, Karachi** shall be at liberty to impose and recover L.D. Charges upto 10%. The penalty shall be applicable only to the extent of items/articles supplied late.
- vi) The **Director, FIA Karachi Zone, Karachi** shall have right to assess, demand and recover any damages suffered by FIA Karachi Zone due to late execution of work i.e. repair of furniture & fixture.





- vii) The Director, FIA Karachi Zone shall not be responsible for non-performance of this agreement due to change in law, rules and policy of the government as notified in official gazette from time to time.
- viii) That all conditions laid down in the rules framed for procurement by the Government shall apply to transactions made under this contract agreement and both parties shall be bound by it.
- 6. This contract agreement shall be construed, and the legal relations created herein will be determined in accordance with the laws of Islamic Republic of Pakistan.
- 9. Any notice required under this contract agreement shall be in writing and shall be effective when received by the addressee at its given address.
- 8. If any term, conditions, or provision in this Agreement is found to be invalid, unlawful or unenforceable to any extent, the parties shall endeavour in good faith to agree to such amendments that will preserve, as far as possible, the intentions expressed in the Agreement. If the parties fail to agree on such amendments, such invalid terms, condition or provision will be served from remaining terms, conditions and provisions, which will continue to be valid and enforceable to the fullest extent permitted by law.
- 9. This agreement may be amended only in writing signed by both the parties.

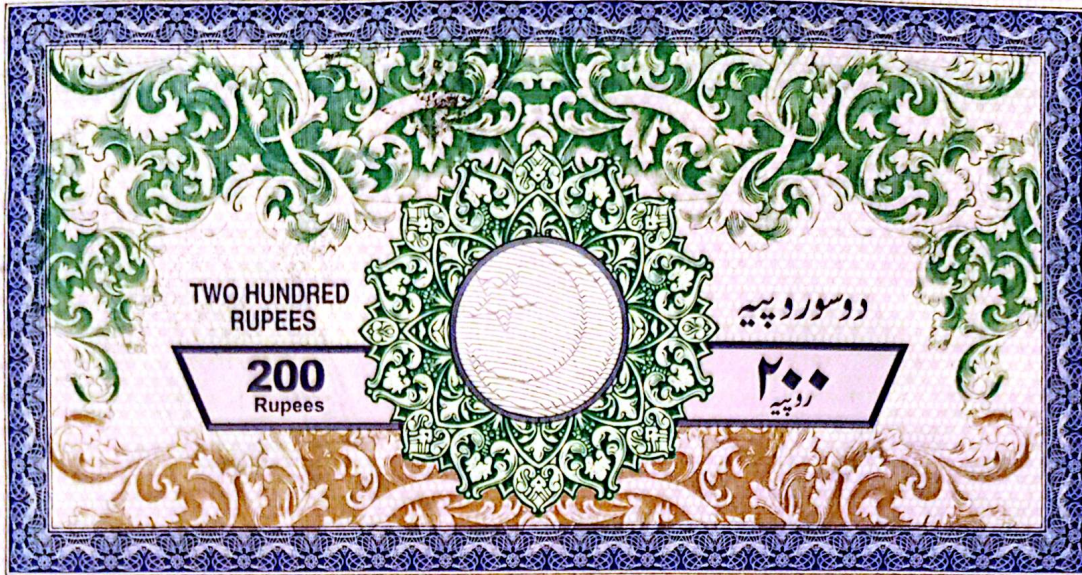
