Bidders are required to get themselves registered on EPADS v2.0 to participate in Bidding process.
6. The e-bids, prepared in accordance with the instructions in the e-Bidding Documents, must be submitted through EPADS v2.0 on or before **September 24, 2026 11:00 AM**. E-bids will be opened using EPADS v2.0 on the same day at **September 24, 2026 11:30 AM**. Manual submission of Bids shall not be entertained.
