Sealed tenders are invited from well-reputed, registered, and experienced firms/contractors for the provision of janitorial, sanitation, and cleaning services at the Office of the Accountant General Balochistan, Quetta for the financial year 2026–2027.

Tender Details & Schedule

- **Procurement Method:** Single Stage – Single Envelope Procedure under Pakistan Public Procurement Authority Rule.
- **Bid Security:** 5% of the total bid amount in the form of a Call Deposit Receipt (CDR) or Pay Order in favor of the **Deputy Accountant General Balochistan, Quetta.**
- **Issuance of Tender Documents:** Available PPRA website
- **Submission Deadline:** 04-09-2026 by Time, 11:30 AM].
- **Bid Opening:** Bids will be opened publicly on 04.09.2026 at 12:00 PM in the office of Deputy Accountant General Office, Quetta, in the presence of bidders or their authorized representatives.

Eligibility Criteria

- **Tax Registration:** Must be listed on the Active Taxpayer List (ATL) of the Federal Board of Revenue (FBR) and registered with the Balochistan Revenue Authority (BRA) for Sales Tax on Services.
- **Relevant Experience:** Minimum [Insert Number, e.g., 3] years of verifiable experience providing janitorial or facility maintenance services to government departments, autonomous bodies, or reputable public sector organizations.
- **Financial Capacity:** Submission of bank statements or audited account reports for the last 3 years demonstrating financial stability.
- **Legal Status:** Non-blacklisting affidavit on a legal stamp paper (attested by a Notary Public) declaring that the firm is not defaulted, blacklisted, or under litigation with any government department.

Terms & Conditions

- Each bidder shall submit a single sealed envelope containing both technical details and the financial proposal/rates.
- The envelope must be clearly marked "**Tender for Provision of Janitorial Services – AG Balochistan.**"
- Bids without the mandatory 5% bid security or submitted after the specified deadline will be rejected immediately.
- Conditional, unsealed, or ambiguous bids will not be entertained.
- The competent authority reserves the right to accept or reject any or all bids in accordance with relevant BPPRA rules.
