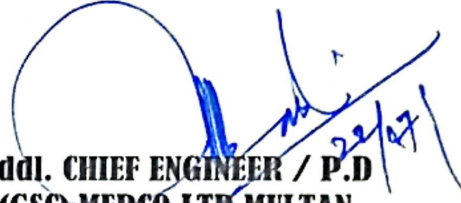

### ELIGIBILITY CRITERIA

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- Pakistan Engineering Council valid certificate with at-least Category **C-6** having Specialization Code **CE-10** must be provided.
  - The bidder shall be in the active tax payer list (ATL) and will provide income returns for last three years.
  - The bidder must have completed at least two contracts of same nature along with its completion successfully as main contractor within Ten years awarded by DISCO/NTDC/WAPDA. The consolidated value of these contracts **must be more than 60% of the estimated / BOQ cost**.
  - The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- Bidding documents containing detailed terms & conditions, method of procurement, procedure for submission of bids, bid security, bid validity, evaluation criteria etc. are available for registered bidders on **EPADS 2.0**.
