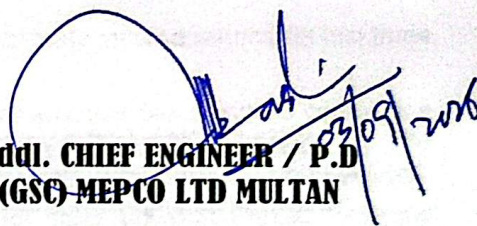

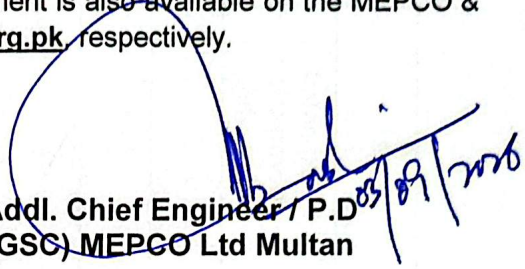

- MEPCO invites **E-Bids** under **Single Stage - Single Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY CRITERIA

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- Pakistan Engineering Council valid certificate with at-least Category C-6 having Specialization Code **CE-10** must be provided.
 - The bidder shall be in the active tax payer list (ATL) and will provide income returns for last three years.
 - The bidder must have completed at least two contracts of same nature along with its completion successfully as main contractor within Ten years awarded by **WAPDA / NTDC / DISCOs**. The consolidated value of these contracts **must be more than 60% of the estimated / B.O.Q Cost**.
 - The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - The average annual turnover with tax returns from FBR should be at least 1.5 times the BOQ amount for last three (03) years, verified from certified auditor and current month bank statement showing **25%** balance amount of work in bank.
 - The contractor having two or more works in hand which are yet not completed and are beyond the stipulated time limit on the part of contractor, in GSC MEPCO will not eligible to participate in the tender.
- Bidding documents containing detailed terms & conditions, method of procurement, procedure for submission of bids, bid security, bid validity, evaluation criteria etc. are available for registered bidders on **EPADS V.2.0**. Interested eligible bidders are requested to register themselves on **EPADS V.2.0** and submit their documents on **EPADS V.2.0**.
- The tenders will be opened publicly in the presence of bidders or their representatives who wish to attend on the aforementioned date & time in the office of the Project Director (GSC) MEPCO Khanewal Road, Multan.
- The electronic bids must be submitted using **EPADS V.2.0** on or before the dates & time as mentioned above in the e-bidding document. Manual bids shall not be accepted. E-bids will be opened on the mentioned dates & time.

- Tender shall remain valid for **150 days** after the opening date. Bid Security/Guarantee in original for fixed amount mentioned in bidding documents in shape of Deposit-at-Call / CDR / Bank Draft / Pay Order OR Bid Security issued by any scheduled Bank of Pakistan, valid for 180 days after the opening date of tender in favor of the Project Director GSC MEPCO Multan shall be submitted in an envelope clearly marked with the tender No. & Title before the E-BID submission deadline in the office of the Project Director (GSC) MEPCO Khanewal Road, Multan, otherwise Bid will be rejected. Copy of the same shall be attached with the E-BID. The conditional tenders shall not be accepted. All rights are reserved.
