PROCUREMENT OF GOODS



1. The PESCO (Peshawar Electric Supply Company) has reserved Funds for the procurement planned for FY 2026-27. The PESCO (Peshawar Electric Supply Company) intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the "PMU-1/2026-27 (ACSR Rail Conductor)" with the reference of "P55403"
 2. The PESCO (Peshawar Electric Supply Company) invites sealed Bids from eligible Bidders for procurement of goods described in the bidding documents on EPADS v2.0.
 3. **Single Stage-Two Envelope** will be used by adopting **Least Cost Based Selection (LCBS)** Technique for selection of most advantageous bidder for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.
 4. All Bids must be accompanied by a Bid Security amounting described in Bid Security Section in Bidding Document in the form of **Call at Deposit, Bank Guarantee**.
 5. The original Bid Security in hard, along with covering letter, must be submitted to the office of the Chief Engineer (Development), PMU PESCO, Peshawar, on or before the bid closing time, failing which the bid(s) shall be considered non-responsive and rejected.
 6. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at <https://epads.gov.pk/opportunities/federal/procurements/55403> for all the interested bidders registered on EPADS v2.0.
 7. The e-bids, prepared in accordance with the instructions in the e-Bidding Documents, must be submitted through EPADS v2.0 on or before **Wednesday, August 12, 2026 10:00 AM**. E-bids will be opened using EPADS v2.0 on the same day at **Wednesday, August 12, 2026 10:30 AM**. Manual submission of Bids shall not be entertained. Those vendors who have not yet registered on the new version of EPADS v2.0, may register themselves on <https://vendors.epads.gov.pk/>.
