INVITATION TO BID

SALE OF 8,197.989 M. TONS ($\pm 15\%$) DAMAGED WHEAT LYING AT VARIOUS PASSCO ZONES

1. Pakistan Agricultural Storage & Services Corporation Limited (PASSCO), a Public Limited Company invites sealed bids from interested parties / firms for the sale of 8,197.989 M.Tons ($\pm 15\%$) of damaged wheat (Unfit / not safe for human consumption) on "As is Where is" basis, lying at various PASSCO Zones, subject to the conditions laid down in bid document. The contract resulting from this invitation to bid shall be governed by the terms and conditions outlined in the bid document. The bidder shall be deemed to have read and understood the conditions thereof and particulars of the material mentioned above.
2. All bidders shall quote their rates inclusive of all taxes and duties, but exclusive of labour, filling, loading / unloading, handling charges, etc. in Rupees per Metric Ton on the prescribed bid form. All bids must be accompanied by a bid security as mentioned in tender document against each centre, on "As is Where is" basis, in the form of Pay Order / Demand Draft / Banker's Cheque issued by any scheduled Bank in Pakistan in favour of PASSCO. Cash / Cheque / Call Deposit Receipt (CDR) / Security Deposit Receipt (SDR) / Bank Guarantee will not be acceptable and the bid shall be rejected.
3. The bid document can also be viewed on the websites of PPRA (<https://www.ppra.gov.pk>) and PASSCO (<https://www.passco.gov.pk>) for information purposes only. However, purchase of the Bid Document on payment of Rs. 3,000/- (Non-refundable) in cash from Account Officer of concerned PASSCO Zonal Office, is mandatory for participation in the Bidding process. Proof of purchase shall be submitted along with the Bid.
