3. Bids shall be submitted electronically through EPADS only. Manual, Physical or hardcopy bids shall not be accepted. Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement / Guidelines or Instructions issued by the Authority from time to time.
4. All Bids must be accompanied by a Bid Security amounting described in Bid Security Section in Bidding Document in the form of Pay Order, Call Deposit, Demand Draft. Where Bid Security is not required by the Procuring Agency, Bidders are required to furnish Bid Security Declaration as specified in Bidding Document. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/>.
5. Bidder(s) are required to get themselves registered on EPADS v2.0 on or before **Tuesday, August 05, 2026 11:00 AM**. E-bids will be opened using EPADS v2.0 on the same day at **Tuesday, August 05, 2026 11:30 AM**. Manual submission of Bids shall not be entertained. 6. Firms will **deposit 2% earnest money** for each lot in favor of "**Pakistan Rangers (Punjab) Security Fund**" which is refundable after **30 June 2027**.
