3. All contractors, irrespective of their enlistment or non-enlistment with *M.E.S will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of registration. Contractors not registered with PEC are ineligible to apply.

4: Contractors born on approved list of MES in categories A, B, C & D and having experience of this type of work may only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (1) of PPRA rules.
