Successful bidders/pre-qualified firms/workshops/suppliers/contractors shall be required to furnish a security deposit/performance guarantee (3% of total estimates) in shape of **pay order/ bank draft in favor of DDO, PPHQ Lahore** separately in each above-mentioned category which will be refunded on expiry of the contract/agreement.

E-bids shall be uploaded on EPADS 2.0 and their attested hard copies in sealed envelopes must be reached at the given address till closing date / time. Bids will be opened in the presence of the bidders or their representatives.
