- Please note that said hiring of rental buildings shall be carried out through EPADS of Public Procurement Regulatory Authority only. All interested applicants are required to register on EPADS to be eligible for participation.
- Tender Notice/Tender Document containing detailed requirements, terms & conditions is available on EPADS at Public Procurement Regulatory Authority (PPRA) website: <https://eprocure.gov.pk>.
- Interested firms/companies/owners are required to submit their proposal documents, in accordance with the instructions in the Tender Document on EPADS on or before **23 July 2026** not later than **1100 hrs** which shall be opened on the same day on EPADS at **1130 hrs**. Manual bids shall not be accepted.
- In addition to the soft copy uploaded on e-PADS, original bid security Rs. 10,000/- (refundable) must be submitted in an Envelope clearly marked in shape of CDR/Bank Guarantee/Demand Draft/Pay Order of any scheduled bank in favour of NADRA REGIONAL HDQ OFFICE LAHORE before E-Bid submission deadline.
- In case the last date for submission of the proposal is declared a public holiday then the next working day will be considered for proposal submission and opening day.
- No brokerage /service charges will be paid in case of real estate agent.
- Bids can also be rejected if owner of selected building fails to produce acceptable required/property documents.
- The competent Authority may reject all proposals at any time prior to the acceptance of a proposal, as provided under Rule-33 of the PPRA Rules, 2004.
