**NOTICE INVITING E-PADS**  
**(Single Stage Single Envelope E-Bidding System)**

Cantonment Board Lahore invites sealed bids from the original manufacturer/ authorized distributors/ suppliers/ contractors registered with Income Tax and Sales Tax Department for the supply of medicines for Cantonment General Hospital, with maximum discount on Retail Price, as per following terms and conditions.

**TERMS AND CONDITIONS: -**

1. Interested bidders can only submit their bids online through E-PADS Portal of PPRA ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)). No hard copy will be issued.
2. The bidder shall submit 2% Bid Security of the estimated cost sealed in envelope in the shape of call deposit at (original) by hand or through courier before closing date & time.
3. The cutoff time for submission of online bids will be 1200 hrs dated 20-07-2026 and shall be opened on same day at 12:30 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
4. Tender will be issued those firms who have valid (CDSL) Central drug sale license are on active taxpayers list of the Federal Board of Revenue. No Manual tender shall be entertained.
5. All the Government taxes will be deducted as per prevailing Government policy.
6. The supplier should be required to supply medicines to Walton Cantonment Board on demand and submit the bill to the Cantonment Executive Officer for payment.
7. At any time, if the price quoted in bills is found higher than the price approved by Ministry of Health, the contract will be terminated & security forfeited and legal action will be taken.
8. The approved contractor has to execute contract on non-judicial stamp paper within fifteen days from the receipt of approval of the Competent Authority.
9. The contractor will be responsible to supply medicine of standard quality and the brand as prescribed. Having sufficient remaining expiry shelf life. Punitive action will be taken as per law in case the supply is found to be substandard or spurious.

Smuggled medicine and the preparation not registered with Ministry of Health will neither be stocked nor supplied.

10. The Cantonment Board/ Executive Office reserve the right to reject the tender as per PPRA's Rule No 33 (1) due to any reason thereof.
11. The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their reasonableness and workability.
12. In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) reasonable amount decided by the undersigned in the shape of call deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
13. Incomplete/ disfiguring/ overwriting/ by hand/ delayed bids shall be declared non-responsive.
14. Any bid received in the contravention of enabling provision of PPRA Rules, 2004 will be declared non responsive by the procuring entity.
15. The validity of tender rates shall be upto 12 Months.
16. Supply order shall be issued subject to the approval of Competent authority.
17. Any information regarding the bid can be obtained from the office of undersigned, during office hours. Furthermore, guidance tutorial has been uploaded on the portal.
