1. Submission of proposal through PPRA EPADS is mandatory.
2. Pre-Bid meeting will be held on **27-08-2026 at 12:00 a.m.** at the address mentioned below to clarify the bidder queries for the captioned work.
3. Interested Bidders are requested to submit their bids electronically through E-PADS on “**Single Stage Two Envelope**” on or before **07-09-2026** till 11:00 a.m. Bids will be open through PPRA EPADS on the same day at 11:30 a.m. Delayed/conditional/telegraphic Bids will not be entertained.
4. Financial Proposal of the technically qualified bidders would be opened electronically in the presence of bidder’s representatives, for which time & date shall be intimated in due course.
5. Bids should be accompanied by **bid security** (refundable) in the form of Call Deposit Receipt (CDR)/pay order or a security issued by a (a) Scheduled Bank of Pakistan or (b) a foreign bank duly counter-guaranteed by a scheduled Bank in Pakistan, or (c) an insurance Company having at least AA rating from PACR/VIS, in favor of “Pakistan Industrial Development Corporation (PIDC)”. Scanned copy of Bid Security shall be submitted along with the technical bid on EPADS; however, the original bid security shall be submitted to PIDC on the address given below before the deadline of submission.
6. The quoted price shall be inclusive of all applicable taxes, duties, levies and other charges.
7. The procurement agency reserves the right to accept or reject any or all bids as per PPRA rules.
8. In case of any unforeseen situation in Clouser of office on the date of opening or if Government declares holiday, the tender shall be opened on the next working day at the same time and venue.
