The **Port Qasim Authority (Port Qasim Authority - PQA)** intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the **"Hiring of 117 Toyota Hiace AC Vans with Chassis Code 224, (Made in Japan) or Equivalent, Hi roof wide body and dual AC, 14-15 Seater, Model 2019 & above"** with the reference of **"P73024"**
2. The **Port Qasim Authority (Port Qasim Authority - PQA)** invites Bids through **EPADS v2.0** from eligible Bidders registered on **EPADS v2.0** for provision of Non-Consultancy Services.
3. **Single Stage-Two Envelope** Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).
4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of **Pay Order** or Bid Securing Declaration on the prescribed format described.

5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at <https://epads.gov.pk/opportunities/federal/procurements/73024>.
6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Tuesday, August 18, 2026 11:30 AM**. E-bids will be opened on the same day at **Tuesday, August 18, 2026 12:00 PM**. Manual submission of Bids shall not be entertained.
