

PROCUREMENT NOTICE

PROCUREMENT OF NON-CONSULTANCY SERVICES

1. The **Lahore Cantonment Board (Military Land & Cantonments)** has reserved Funds for the procurement planned for FY **2026-27**. The **Lahore Cantonment Board (Military Land & Cantonments)** intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the **"Hiring of One (01) 250 HP Crawler Dozer on Monthly Rental Basis for Municipal Solid Waste Dumping and Disposal Operations at Lakhodair Dumpsite, Lahore Cantonment"** with the reference of **"P62477"**

2. The **Lahore Cantonment Board (Military Land & Cantonments)** invites Bids through **EPADS v2.0** from eligible Bidders registered on **EPADS v2.0** for provision of Non-Consultancy Services.

3. **Single Stage-One Envelope** Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).

4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of **Pay Order, Banker's Cheque, Call at Deposit, Bank Guarantee** or Bid Securing Declaration on the prescribed format described.

5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at **<https://epads.gov.pk/opportunities/federal/procurements/62477>**.

6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Friday, July 31, 2026 10:00 AM**. E-bids will be opened on the same day at **Friday, July 31, 2026 10:30 AM**. Manual submission of Bids shall not be
