All interested bidders must register themselves at EPADS using link <https://vendors.epads.gov.pk>.
- National Competitive Bidding (NCB) will be conducted in accordance with “**Single Stage Two Envelope Bidding Procedure**” for Tender No 2, 3 and “**Single Stage Single Envelope Bidding Procedure**” for Tender No 04,05,06 in line with Public Procurement Rules 2004.
- The prospective bidder shall submit Bid Security of the amount in the name of **Hazara Electric Supply Company Limited Abbottabad** as mentioned in bidding documents for each tender. The original Bid Security shall be delivered in the Room No 209, office of Manager (SCM) HAZECO HQ, Gulistan Colony College Road, Abbottabad before the bid closing time as scheduled above and the scanned copy of bid security must be uploaded along with e-Bid on EPADS, failing which the bid(s) shall be considered non-responsive and rejected.
