

E-AUCTION NOTICE (REF # D10157)

The Utility Stores Corporation of Pakistan (USCP), Ministry of Industries & Production, intend to auction of Poly Granule/Poly and Shopping Bags located at USC Own Brand Warehouse Plot No.290-A Industrial Area, Sector I-9/3 Islamabad through EPADS 2.0. 2. The auction process shall be conducted through e-PADS 2.0 (Tender/Reference No. D10157). Interested bidders may submit their bids electronically through e-PADS 2.0 from 25-06-2026 up to 09:00 A.M. on 15-07-2026. The Disposal Committee shall open the bids at 11:00 A.M. on 15-07-2026 and process the auction in accordance with the applicable rules and procedures.

3. The quoted bid price shall be inclusive of all applicable taxes, duties, levies, charges, sales tax, Federal Excise Duty (FED), and any other government-imposed taxes or charges.

4. Any Pakistani citizen possessing a valid Computerized National Identity Card (CNIC) issued by NADRA, along with valid NTN and Sales Tax Registration (where applicable), may participate in the auction. Government employees and defaulters of any Government Department shall not be eligible to participate. Companies/Firms may participate through their duly authorized representatives.

5. Bidders shall submit their offers on a lot-wise basis for the complete quantity of Poly Granules Raw Material and Poly/Shopping Bags (all varieties) included in each lot. The whole lot shall be awarded to the bidder offering the highest responsive bid. Partial bids against individual items within a lot shall not be entertained and shall be treated as non-responsive.

6. The successful bidder shall be responsible for lifting the awarded material from the designated locations within thirty (30) days from the date of issuance of the award letter and completion of 100% payment, as applicable. All loading, transportation, handling, and related expenses shall be borne by the successful bidder.

7. Each bidder shall submit a Pay Order/Demand Draft equivalent to 2% of the reserve price of the respective lot in favor of Utility Stores Corporation of Pakistan (Pvt.) Limited as a bid security prior to the auction closing date and time. The bid security of unsuccessful bidders shall be refunded after completion of the auction process, whereas the bid security of the successful bidder shall be retained.

8. Each bidder shall submit the prescribed bid form along with an affidavit on Rs.100/- stamp paper, declaring that he/she is neither a Government employee nor a defaulter of any Government Department, Autonomous Body, or Public Sector Organization.

9. Bidders are required to quote their best and final offer, inclusive of all applicable taxes and duties. Conditional, alternate, incomplete, or non-compliant bids shall be rejected as non-responsive. Valid copies of NTN Certificate, Sales Tax Registration Certificate (where applicable), and CNIC must be submitted with the bid.

10. The auction/disposal documents, including detailed terms and conditions, may be downloaded free of cost from the Utility Stores Corporation website (<https://www.usc.org.pk>) and the PPRA website (<https://ppra.gov.pk>). Interested bidders must be registered with e-PADS to participate in the auction and to access all relevant information and documents.

11. The successful bidder shall, prior to lifting of the material, submit an affidavit on non-judicial stamp paper of Rs.100/-, duly attested, undertaking that:

"The Poly/Shopping Bags offered for disposal bear the logo/branding of Utility Stores Corporation of Pakistan (USC) and, therefore, shall not be sold, distributed, reused, or marketed in their original form. The material shall only be utilized for recycling, shredding, conversion into granules, or any other lawful industrial processing purpose. The bidder shall be solely responsible for any misuse, unauthorized sale, distribution, or violation of this undertaking and shall indemnify USC against any claims, losses, liabilities, or legal consequences arising therefrom."

Failure to submit the required affidavit shall result in cancellation of the award and forfeiture of the bid security, without prejudice to any other legal remedies available to USC.
