1. Federal Government Educational Institutions (C/G) Wah Region intends to invite tenders from interested construction firms for **Construction of New BS Block (G+1) in FG Post Graduate College for Women, Wah Cantt.**
2. **Construction Firms Must Have: -**
 - (i) Copy of CNIC.
 - (ii) Valid ATL & PEC registration.
 - (iii) Bank statement for last 3x months (with handsome closing/ current bal) duly signed/ stamped by the concerned bank.
 - (iv) Valid NTN/ GST registration.
 - (v) Affidavit regarding Non Blacklisting (issued after uploading of tender).
 - (vi) Details of previous contracts to determine experience.
 - (vii) Satisfactory performance certificate(s) issued by FGEIs, Wah Region, for contracts previously executed.
3. As **two stage bidding procedure** will be opted, the bidders shall submit **technical proposals** without price, according to the required specifications by **24 Aug 2026 before 11:00 AM**. The technical proposal shall be evaluated and may be discussed with bidders regarding any deficiencies & unsatisfactory technical features, on the same day at **12:00 PM** in ROW.
4. After such discussion, all the bidders shall be permitted to revise their respective technical proposals to meet the requirements. The bidders whose technical proposals or bids will not be rejected and who will be willing to confirm their bids after revised technical requirements, shall be invited to submit a revised **technical proposal** along with the **financial proposal (Separately)** completed in all respects duly signed and supported with documentary evidence in sealed envelope by **26 Aug 2026 before 11:00 AM**. Only relevant documents are to be attached.
5. Tender will be opened on **26 Aug 2026 at 11:30 AM** at FG TTC, Wah in the presence of concerned contractor or their nominated rep.
6. Bids forms can be obtained from ROW for **Rs.5,000/-** (Non Refundable) from **15 Aug 2026 to 21 Aug 2026** during office hours and will be **submitted** on above mentioned dates.
7. **2nd** attempt for bids will be carried out after **15 days** (subj to failure of **1st** attempt)
8. Earnest money/ Security @ 5% of Bid in shape of CDR will be deposited in favor of Regional Dir, FGEIs C/G Regional Office, Wah Cantt.
9. The companies providing unsubstantiated/ incorrect information will be liable for legal action and subsequent disqualification. **Regional Director, ROW** reserves the right to reject any or all bids as per PPRA rules.
10. The bidder should be at least **C-4 Cat PEC registered firm**.
