1. Tenders for supply of Animal Ration are invited from the Government registered firms on free delivery basis as per following qty in all over Punjab (Sialkot, Narowal, Kartarpur, Kala Katai, Lahore, Ganda Singh Wala, Kanganpur, Wagha, Moujgarh Mandi Yazman, Head Sulemanki, & Mandi Bahauddin for the period from 1 July 2026 to 30 June 2027: -

2. HQ Pakistan Rangers (Punjab) Zarrar Shaheed Road, Lahore invites E-Bids from eligible Bidders for procurement of goods described in the bidding documents on EPADS V2.0.

3. According to above mentioned ration quantity, every firm will mention price of every ration item separately per Kg. Rates quoted will be inclusive of transportation and all taxes.

4. Single Stage - One Envelope will be used by adopting Least Cost Based Selection (LCBS) Techniques for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.

5. **Bids must be accompanied by a Bid Security in the form of Pay Order / CDR in favor “Director General Pakistan Rangers (Punjab) Lahore”. The prospective bidders shall upload scan copy of bid security on E-PADS and shall provide the original pay order / CDR at the time of opening of technical bids.**

E Bidding documents, containing detailed terms & conditions, specifications and requirements etc are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk>.

6. Each Firm will deposit 2% earnest money in favor of “**Director General Pakistan Rangers (Punjab) Lahore**” in the form of CDR, Pay Order / Bank Draft which is returnable. On acceptance of tenders the successful tenderer shall have to deposit security equivalent to **5%** of total tender cost in **favor “Pakistan Rangers (Punjab) Securities Fund”** within 15 days of the receipt of acceptance notification. All firms will mention their sales tax registration and NTN number in their quotations otherwise quotation will be rejected.

7. Bidders are required to get themselves registered on EPADS V2.0 on or before 21 July 2026 11:00 AM and **submit their bids online through E-PADS**. E-bids will be opened using EPADS V2.0 on 21 Jul 2026 at 11.30 AM **in the Headquarters Pakistan Rangers (Punjab) in the presence of bidders authorized representatives to attend the bid opening process.**

Firms to deposit 10 kg sample of each item freshly approved / passed from PCSIR (specification of samples att in bid documents) before bid opening i.e 21 Jul 2026 at 11.30 AM.

8. Payment of supplied ration will be subjected to sample clearance of qualified Firm from AFIN (Army Institute of Nutrition) through lab testing. Charges of testing will be borne by the firm.

9. Director General Pakistan Rangers (Punjab) reserves the right to reject any or all offers/bids with assigning reasons, prior to acceptance of tender.
