- Only e-bids are acceptable, all the interested Bidders are directed to apply through E-Pak Acquisition & Disposal System (E-PADS) Portal Online (<http://www.epads.gov.pk>) and also upload all the mandatory information as required in the bidding documents.
- Tender will be opened on "Single Stage One Envelope basis".
- The prices should be firm and final on DDP basis and without involving any foreign exchange.
- The bid shall be valid for a period of 60 days for Tender No. 36, 37 and 38 and 120 days for Tender No. 32 to 35 and Tender No. 39 to 45.
- The bidder shall submit sealed Bid security/Guarantee in original mentioned above against each tender valid for 28 days beyond bid validity i.e. 148 days against Tender No. 32 to 35 and Tender No. 39 to 45 and 88 days against Tender No. 36, 37 and 38 in the form of Bank Guarantee/CDR issued by any scheduled Bank of Pakistan (having rating A+ or above) in favour of Chief Executive Officer IESCO Islamabad, before the bid closing time, failing which the bid(s) shall be considered non-responsive.
- The bid should be for full quantity of tender/lot/item and bid for less quantity of tender/lot/item will not be accepted.
- The price quoted by the bidder on E-PADS Version 2.0, shall be inclusive of all taxes and duties applicable as per Law however, GST is reimbursable on the submission of original invoices/forms.
- The bidder should have valid prototype approval (if applicable) at the time of opening of bid.
- IESCO reserves the rights to reject all bids prior to the acceptance of a bid.
