The **National Highway Authority** has received financing from the OPEC Fund for International Development (“the Fund”) towards the cost of the **Construction of Hyderabad – Sukkur Motorway (M-6)**; and intends to apply part of the proceeds toward payments under the contract for **Section-3: Nawabshah to Naushahro Feroz (Km 250+500 to Km 315+300) [64.61 km approximately]**
2. The **National Highway Authority** now invites sealed bids from eligible bidders for **Construction of Hyderabad – Sukkur Motorway (M-6); Section-3: Nawabshah to Naushahro Feroz (Km 250+500 to Km 315+300) [64.61 km approximately]**
3. Bidding will be conducted through the International Open Competitive Bidding (IOCB) as specified in Fund’s Principles for Procurement of Goods, works and Services (*the Principles*) and Procedures for procurement of goods, works and non-consulting services (the Procedures), and is open to all eligible bidders.
4. Interested eligible bidders may obtain further information from the office of **General Manager Procurement and Contract Administration (P&CA), NHA – Head Quarters, P.O. A complete set of bidding documents in *English* may be purchased by interested bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of **PKR 10,000/-**. The method of payment will be *Pay Order/Demand Draft in favor of National Highway Authority*. The document will be available to pick up from the office stipulated in BDS during the working time from Monday to Friday except public holiday. *The Bidding documents and all related information will be uploaded on www.nha.gov.pk.*
6. Bids must be delivered at **NHA Auditorium**, 2nd Floor, Room No. 223, NHA HQ, Islamabad on or before **11:00 Hours, 11th August 2026**. Electronic bidding **will not be permitted**. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend.
7. All bids must be accompanied by a *Bid Security* of **PKR 1.27 billion or US\$ 4.51 million**
