 - c. Shifting, installation, testing and commissioning of CCTV and security surveillance systems.
 - d. Shifting, installation, testing and commissioning of telephone exchange (PBX) and communication systems.
 - e. Relocation, installation and commissioning of IT equipment, networking infrastructure and data cabling.
 - f. Supply, installation, testing and commissioning of access control systems, including card readers, electronic locks and related security equipment.
 - g. Design, fabrication and installation of exterior and interior signage, wayfinding signs and official displays for the Chancery premises.
 - h. Procurement and installation of flagpole
