PROCUREMENT OF CONSULTANCY SERVICES

The Hydrocarbon Development Institute of Pakistan (Hydrocarbon Development Institute of Pakistan) intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the consultancy services of “Hiring The Services of Chartered Accountant Firm for Commercial Audit of Self Generating Units (2025-26, 2026-27 & 2027-28)”.

2. The Hydrocarbon Development Institute of Pakistan (Hydrocarbon Development Institute of Pakistan) invites RFP through EPADS v2.0 from eligible Bidders registered on EPADS v2.0 for provision of Consultancy Services.

Single Stage-Two Envelope Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).

4. All proposals must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of Pay Order or Bid Securing Declaration on the prescribed format described.

5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/>.

6. The RFP, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before Friday, July 17, 2026 10:30 AM. Proposals will be opened on the same day at Friday, July 17, 2026 11:00 AM. Manual submission of RFPs shall not be entertained. Those consultants/Firm who have not yet registered on the new
