6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Thursday, August 6, 2026 03:00 PM**. E-bids will be opened on the same day at **Thursday, August 6, 2026 03:30 PM**. Manual submission of Bids shall not be entertained. Those vendors
