- iii. The Contractors / Firms shall be registered with SECP as a company or business registered FBR and included in Active Taxpayer List (ATL) of Income Tax/Sales Tax maintained by FBR.
- iv. All applicable taxes shall be deducted at the rate prescribed under tax laws of Pakistan from all payments for services rendered by a Contractor/Firm/Supplier.
- v. **Successful bidders/ prequalified firms/ suppliers/ contractors shall be required to furnish a Security deposit / performance guarantee amounting to Rs.30,000.00 (Rupees Thirty Thousand only) in shape of pay-order issued in favor of DDO CRHQ IBD, Islamabad, which will be refunded on expiry of the contract agreement.**
- vi. **The firms/suppliers/contractors who fulfill the criteria and expertise may submit their proposal / bids through EPADS and Hard Copy of Proposal /Bid document must reach at the office address given below on or before 11 August 2026 at 11:00 AM.**
