PROCUREMENT OF NON-CONSULTANCY SERVICES

1. The Faisalabad Electric Supply Company (Administration Directorate) has reserved Funds for the procurement planned for FY 2026-27. The Faisalabad Electric Supply Company (Administration Directorate) intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the "Repair of Burnt ISUZU NMR Truck (Model 2024)" with the reference of "P92044".
2. The Faisalabad Electric Supply Company (Administration Directorate) invites Bids through EPADS v2.0 from eligible Bidders registered on EPADS v2.0 for provision of Non-Consultancy Services.
3. **Single Stage-Two Envelope** Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Quality and Cost Based Selection (QCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).
4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of **Pay Order, Call at Deposit, Bank Guarantee, Demand Draft** or Bid Securing Declaration on the prescribed format described.
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System available (EPADS) at <https://epads.gov.pk/opportunities/federal/procurements/92044>**.
6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before **Monday, September 7, 2026 03:00 PM**. E-bids will be opened on the same day at **Monday, September 7, 2026 03:30 PM**. Manual submission of Bids shall not be entertained.
