- iv. All applicable taxes shall be deducted at the rate prescribed under tax laws of Pakistan from all payments for services rendered by a Contractor/Firm/Supplier.
- v. **Successful bidders/ prequalified firms/ suppliers/ contractors shall be required to furnish a Security deposit amounting to Rs.25,000.00 (Rupees Twenty Five Thousand only) in shape of pay-order issued in favor of DDO AJK RHQ IBD, Muzaffarabad, which will be refunded on expiry of the contract agreement.**
