TENDER NOTICE PURCHASE OF DRUG & MEDICINE 2026-27

Sealed tenders are invited from the firms/Authorized Dealers having proper shops and telephone facility, duly registered with sales tax authorities alongwith vendor numbers/NTN Number and also having Valid Medicine Distributing Authorization/ License for Purchase of Drug & Medicine for the Financial Year 2026-27. Tender can also be downloaded from the websites Public Procurement Regulatory Authority www.ppra.gov.pk as well as EPADS.

- i. Interested parties/firms can also obtain list/tender documents from the office of undersigned till 17 Sep, 2026 before closing of office hours.
- ii. Security worth **Rs.187,500/- (Rupees One Hundred Eighty-Seven thousand & five Hundred Only) (Single Stage-Single Envelop Basis)** for supply of Drug & Medicine is required to be deposited in favour of Chief Security Officer ASF Islamabad Airport. Security deposits will be released/refunded within a fortnight to unsuccessful bidders and in case of successful bidders after 30th June, 2027 or successfully completion of supply of final supply order.
- iii. Rates may be quoted for which will remain valid up to **30th June, 2027**. Sub-standard items will not be acceptable and defaulters/suppliers will be blacklisted as per PPRA rules and such items will be purchased from the open market at the cost and risk of the supplier.
- iv. Firms will be bound to supply/deliver the goods on the approved rates throughout the year/specify given time and even on short Notice at their own transport in ASF Medical Center ASNS Garrison Islamabad Airport.
- v. The Tender Documents must accompany the following certificates:
 - Firms' registration Certificates.
 - National Tax Number.
 - Medicine Distribution Certificate / License / DRAP
 - Sales Tax Registration Certificate.
 - Vendor Number.
 - Bank Account No/IBAN No.
- vi. Only typed quotation will be accepted. Use of white fluid or over writing will not be accepted. All firms are directed to quote their rates on online e-procurement Portal EPADS as well **as original** bid/rates (Pay Order, Stamp paper, Rate List, NTN Certificate, GST Certificate) must be submitted in hard form (hard copy) in the office of undersigned by the bidders.
- vii. The Suppliers are requested to furnish an affidavit on stamp paper valuing Rs.100/-that the firm is not blacklisted and has no dispute with any Government Organization(s).
- viii. The Competent Authority reserves the right to accept or reject any tender by whole or partially with assigning proper justifications/deficiency (if any).
- ix. The Competent Authority also reserves the right to cancel the contract entirely during the currency of year if items are found sub-standard or short in quantity and also not supplied timely. The security amount will be fortified and the firm will be blacklisted.
- x. Sealed Tenders Complete in all respect may reach the Admin Office ASF Islamabad Airport on or before **18 September, 2026** (Up to 1000 hours). Tenders/ bids will be opened on the same day i.e. 18 Sep, 2026 at 1030 hours in Admin Office ASF IIAP Islamabad.
