TENDER NOTICE

Pakistan Bait-ul-Mal is an autonomous organization of the federal government. Pakistan Bait-ul-Mal has established 30 Women Empowerment Centers (WECs) in Khyber Pakhtunkhwa. Pakistan Bait-ul-Mal (PBM), invites e-bids separately Technical and Financial from well reputed Manufacturers, firms and General Order Suppliers, registered with Income Tax and Sales Tax Department, for **Procurement of Cloth and Gadgets** under single stage two envelope procedure for trainees of thirty (30) PBM Women Empowerment Centers (WECs) located at Khyber Pakhtunkhwa.

2. Standard Procurement Document/ advertisement, containing detail of items, specification and other terms and conditions are available at the website of PBM www.pbm.gov.pk as well as PPRA website www.ppra.gov.pk.

3. E-Bids prepared in accordance with PPRA rules and instructions given in the Standard Procurement/Bidding Document, shall be submitted online at E-Pak Acquisition & Disposal System (www.epads.gov.pk), on or before **10-08-2026 till 11:00 AM** accompanied by a call deposit receipt / pay order/ Bank draft as earnest money (refundable/ interest free) amounting to **Rs. 500,000/-** in favour of Director PBM Provincial Office, Khyber Pakhtunkhwa Peshawar. Copy of Call Deposit must be uploaded on EPADs.

4. The original pay order/ Bank draft/ CDR must be delivered at PBM Provincial Office Khyber Pakhtunkhwa on or before **10-08-2026 till 11:00 AM**.

5. Technical bids will be opened on the same day at **11:30 AM** in Pakistan Bait ul Mal, Provincial Office, Khyber Pakhtunkhwa in presence of bidders or their representatives. The firm / supplier must bring samples of the Cloth and Gadgets at the time of opening of Technical Bids. Date and time of opening of Financial Bids of technically qualified firms/suppliers will be intimated later. **Bids will be evaluated item-wise.**

7. Successful firm (s)/bidder (s) will be bound to supply goods on approved rates for one year from the issuance of first supply order at designated places. The Cloth and Gadgets items will be inspected at the Godown of the supplier(s)/ vendor(s) prior to supply of items to the WECs.

8. PBM reserves the right to reject any/all bids at any time in accordance with PPRA's Rules.
