Pakistan Television Corporation Limited (PTVC), the national public service broadcaster, invites applications from eligible firms/companies for pre-qualification under PPRA Rule 16-A through framework agreement and enlistment on a centralized panel of service providers for procurement of goods and services, nationwide on as-and-when required basis initially for a period of one year, extendable for two years on annual basis with mutual consent, for PTV Headquarters Office, PTV News/Pakistan TV/ETV Centre (PTV Home)/PTV Sports/PTV Global/PTV Drama & Film Academy, all Provincial Television Centers (Karachi, Quetta, Lahore, Multan, Peshawar, Muzaffarabad) and Rebroadcast Stations (RBSs) for the Financial Year 2026-2027.

2. The pre-qualification shall be conducted under National Competitive Bidding in accordance with Public Procurement Rules, 2004 (as amended from time to time) and applicable Government instructions. Interested bidders must be registered with relevant tax authorities, active taxpayers and fulfill the eligibility requirements mentioned in the bidding documents.
3. Complete bidding documents may be obtained during office hours, after publication of this notice, from the office of the Head of Procurement, PTV Headquarters Office, Islamabad. The cost of the bidding documents shall be **PKR 2,000/- (non-refundable)** in the shape of **Pay Order / CDR in favor of Pakistan Television Corporation Limited (PTVC)**, payable in accordance with applicable PPRA procedures.
4. Only bids submitted after successful payment of the prescribed bidding document fee shall be considered eligible. Failure to submit the required bidding documents fee shall result in disqualification of the bidder and rejection of the applications in accordance with PPRA Rules.

The applications/Proposals, prepared in accordance with the instructions contained in the bidding documents, must reach the office of the Controller Audit / Chairman Senior Tender Committee, PTV Headquarters, Constitution Avenue, F-5/1, Islamabad, on or before **22.07.2026**.
