- iii. The Contractors / Firms shall be registered with SECP as a company or business registered FBR and included in Active Taxpayer List (ATL) of Income Tax/Sales Tax maintained by FBR.
- iv. All applicable taxes shall be deducted at the rate prescribed under tax laws of Pakistan from all payments for services rendered by a Contractor/Firm/Supplier.
- v. **Successful bidders/ firms/ suppliers shall be required to furnish Bid Security as mentioned above against each category in shape of pay-order issued in favor of DDO CRHQ IBD, Islamabad. And scanned copy of the pay-order must be uploaded on EPADS.**
- vi. **The firms/suppliers who fulfill the criteria and expertise may submit their bids through EPADS and Hard Copy of Bid document must reach at the office address given below on or before 10 August 2026 at 12:00 PM.**
