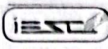

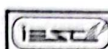

2. The IESCO (Islamabad Electric Supply Company (IESCO)) invites Bids through **EPADS v2.0** from eligible Bidders registered on **EPADS v2.0** for provision of Non-Consultancy Services.
3. Single Stage-Two Envelope Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting Quality and Cost Based Selection (QCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004
4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of Pay Order, Banker's Cheque, Call at Deposit, Bank Guarantee, Demand Draft.
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/>. The Bid shall be valid for a period of 120 days whereas, the bid security in favor of CEO IESCO, valid for 28 days beyond bid validity (Total 148 days)

E-bids will be opened on the same day at **Monday, August 10, 2026 11:00 AM**. Manual or conditional submission of Bids shall not be entertained.
