- Only E-bids are acceptable, all the interested bidders are directed to apply through E-Pak Acquisition & Disposal System (E-PADS Version 2.0) Portal Online (http://www.epads.gov.pk) and also upload all the mandatory information as required in the bidding documents. - Single Stage-Two Envelope Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004. - All Bids must be accompanied by a Bid Security as mentioned above in the form of Pay Order, Call at Deposit and Bank Guarantee. The Bid shall be valid for a period of 90 days whereas, the bid security in favor of CEO IESCO, valid for 28 days beyond bid validity (Total 118 days). - E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at https://vendors.epads.gov.pk/ - The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before Thursday, July 30, 2026 10:30 AM.
