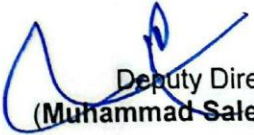
Government of Pakistan, Ministry of Interior & Narcotics Control, Regional Directorate Anti Narcotics Force Sindh requires **Pre-Qualify for Tender Repair Maintenance for Financial Year 2026-27 from GST holders, firms, vendors**. Each List is uploaded with the tender on PPRA Website. Details are as under: -

- a. **Transportation of Goods.**
- b. **Conference / Seminar / Workshop.**
- c. **Exhibition, Fair and Others.**
- d. **Transport (Repair & Maintenance of Vehicles).**
- e. **Machinery Items (AC, Lift, Photocopier Machine, Generator Repair & Maintenance).**
- f. **Repair of Office Buildings.**

TERMS & CONDITIONS

1. Tender Documents may be downloaded from PPRA website or can be obtained from address given below for Rs.1000/- .
2. The prospective bidders are required to submit their bids in sealed enveloped on given office address mentioning "**Tender Documents**" on front side of envelope.
3. Last date for submission of bids is **25 September 2026 (Friday) which will be opened on the same date at 11:30 AM** in the presence of representatives of firms, who desire to attend.
4. A bid bond, in the shape of bank draft / pay order amounting to Rs. 50,000/- (Rupees fifty thousand only) (refundable), for each category, should be submitted (in original) with bids before closing of Tender hours on the name of "Regional Directorate Anti Narcotics Force Sindh". No such application will be entertained without earnest money mentioned in tender documents.
5. All bidders participating in the tender should be registered with FBR and must be included in active tax payer list maintained by FBR.
6. Bidders / Vendor must have past 3 years' experience in relevant field with Government Departments.
7. Tender will be decided on the Cost and Quality Basis.
8. Payment shall be made through AGPR cheque after receipt of your bill within appropriate time after completion of necessary official procedures.
9. All currency in the proposal shall be quoted in Pakistan Rupees (PKR) inclusive of all applicable taxes.
10. The bidder is hereby informed that the Government shall deduct taxes at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
11. The firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding process.
12. The firm providing undertaking and original affidavit on judicial stamp paper for non-blacklisting from any Government Department and other Semi Government office.
13. The Authority reserves the right to reject all the applications as per PPRA Rules-2004.
14. Earnest money of successful bidder(s) will remain in custody of the office throughout FY2026-27 as performance guarantee.
15. Documents required to be submitted for pre-qualification of the firm / company is as under:-
 - a. Registration Certificate of FBR for SST& NTN.
 - b. Certificate that there is no case of litigation against firm/company.
