1. Electronic bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc, are available for the registered bidders on EPADS.
2. Application should be submitted electronically only through EPADS, manual submission of application is not allowed.
3. The rates should be inclusive of all applicable Govt Taxes / Duties etc. The payment will be made after deducting all the applicable Govt taxes at the time of payment.
4. The bidder shall furnish earnest money in the shape of a pay Order, equivalent to 3% of the estimated value of their total bid value (Gross Total), in favor of Directorate Intelligence & Investigation (Inland Revenue) Hyderabad.
5. The electronic bids must be submitted by using EPADS on or before 21.09.2026 at 02:00 PM which will be opened on the same day at 02:30 PM in the committee Room situated at 1st Floor of Directorate of Intelligence & Investigation IR Hyderabad, Bungalow No. 184 Civil Line, Tariq Road, Hyderabad through EPADS.
6. The quotations must be submitted inclusive of all taxes.
7. The contract will be awarded to the most advantageous bid.
8. The bidder should enclose a copy each of NTN certificate, Sales Tax Registration Certificate, and CNIC of the proprietor.

9. Incomplete tender will not be accepted in any case.
10. Rate to be quoted shall be inclusive of GST and all taxes and shall be valid up to 30.06.2027. However, the procuring agency may extend contract period beyond 30.06.2027 till finalization of next tender.
