 6. The RFP, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Monday, August 17, 2026 11:00 AM**. Proposals will be opened on the same day at **Monday, August 17, 2026 11:30 AM**. Manual submission of RFPs shall not be entertained.
