4. Original Bid Security Instrument Must be submitted in the office of undersigned before the online submission deadline of the bid otherwise respective bid shall not be opened.

ELIGIBILITY CRITERIA

1. The Bidders meeting the following requirements will be eligible for participation in the bidding.
- Identity Card of Supplier / Managing Partner / Director of the firm.
 - The bidder must have successfully completed at least two contracts of a similar nature as the main contractor within the last Ten (10) years, awarded by WAPDA, NTDC, or DISCOs, and must provide successful completion certificates for these contracts. The cumulative value of the completed contracts must be more than 40% of the quoted cost.
 - The bidder shall be in the active tax payer list (ATL), and will provide Income Tax Returns for last three years.
 - The firms, manufacturers, and suppliers shall submit valid Sales Tax Registration issued by the Punjab Revenue Authority (PRA), wherever applicable.
 - The firms, manufacturers, and suppliers shall submit valid General Sales Tax (GST) Registration issued by the Federal Board of Revenue (FBR).
 - The bidder should have an Average Annual Turnover half of the quoted amount against each work during last three years certified from audited financial statement.
 - Bidder shall demonstrate Cash or Cash Equivalents equal to 10% of contract value and current contract commitments. In this regard bidder shall provide the bank statements of last one year.
 - All bids must be accompanied by a Bid Security amounting to 5% on Estimated amount each in favor of Project Director GSC FESCO Faisalabad of any scheduled bank of Pakistan uploaded on E-PADS & original Bid Security in an envelope clearly marked with Tender No. and title shall be submitted in the office of Project Director GSC FESCO Faisalabad, before the online submission deadline of the bid otherwise respective bid shall not be opened. Bid security shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
 - The bids will be opened at the office of Project Director GSC FESCO Faisalabad in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
 - In case of unforeseen holiday announced / unannounced by the Government, the tender will be opened on next working day at the same time and venue.
 - FESCO reserves all its rights regarding rejection of tenders without providing any justification as defined in Clause-33(1) of PPRA Rules-2004 amendment up to 2022.
