**1. Procedures of Open Competitive Bidding:**

Single Stage Two envelope procedure as per FPPRA rules 2004 clause 36 (b) will be adopted for tender process. Bid shall comprise of single package containing two separate envelopes each envelope shall contain separately sealed financial proposal and Technical proposal. Envelope shall be marked as "Financial Proposal" and "Technical Proposal" in bold and legible letter to avoid confusion.

The tender will be opened through E-Pads new version 2.0.

Tender documents can be obtained from E-Pads new version 2.0/FPPRA Website.

The said tender notice will also be available on E-Pads, FPPRA & GEPCO Website.

**2. Who can Participate?**

- Contractor who has valid PEC registration renewal for the year 2025-26 under code as mention below.
- The average annual turnover with Tax return from FBR should be as per tender notice's BOQ amount for last 2 years, verified from the certified auditor.
- Current Bank statement should be from date of publication of tender in newspaper upto date of opening of tender showing 15% balance amount of individual works.
- In proof of experience the contractor is required to submit at most 02 No. valid work orders of same nature having cumulative cost equal to or more than 100% of BOQ amount along with work completion certificates obtained from work order issuing authority for executing during the last 05 years.
- In case of JV as a successful bidder will have to submit performance security in Joint Bank Account, Joint active NTN in FBR & PRA also the agreement must be on judicial stamp paper of worth Rs. 3000/- attested from Notary Public is required.

**3. Earnest Money.**

- (i) Original Bid Security for the period of 120 days in the shape of Bank Draft, Pay order, CDR or a Bank Guarantee issued by a scheduled bank in Pakistan @ 2% of BOQ cost must be supplied along with technical bid.
- (ii) The successful bidder will have to submit @ 10% of the Contract Price as performance Security in the form of Bank Draft, Pay order, CDR or Bank Guarantee after issuance of LOI.

**4. Other Conditions.**

- (i) The Contractors are required to attach their registration certificates (Active), issued from PRA for PST along with bid.
- (ii) In addition to experience the bidder has to submit documents/ company profile which prove that bidder has been involved in the Grid Station & Transmission Line work for the last five years and has sound financial position.
- (iii) Authority letter is required on 100 rupees judicial stamp paper for Contractor representatives to receive tender documents / participation in the tender process.
- (iv) Cutting/ Overwriting is not allowed in tender documents.
- (v) Tendered rates should be filled in figure as well as in words and tender should be signed as per general directions given in the tender documents.

**5. Note.**

The Department/Company reserves the rights to accept or reject the tender as per PPRA Rules. (No conditional tender will be accepted).
