EXPRESSION OF INTEREST (EOI)

Prequalification of Consulting Firms for Third-Party Evaluation / Validation (TPE/V) of Education Sector Development Projects

The Ministry of Federal Education & Professional Training (MoFEPT), Government of Pakistan, invites Expressions of Interest (EOI) from well-established, experienced and professionally competent consulting firms, including Joint Ventures (JVs) and Consortia, for prequalification to undertake independent Third-Party Evaluation / Validation (TPE/V) of its development projects and Programmes.

The prequalification process is being conducted in accordance with the Public Procurement Rules, 2004 and the PPRA Procurement of Consultancy Services Regulations, 2010. The panel of prequalified firms shall remain valid for a period of three (03) years, during which firms may be invited to participate in assignment-specific Requests for Proposals (RFPs) under the applicable PPRA procurement method. Interested eligible firms may apply for one or more of the following Lots, subject to meeting the prescribed eligibility and evaluation criteria:

Lot	Area of Specialization
Lot-1	Infrastructure, Civil Works & Allied Procurement Evaluation
Lot-2	Information Technology & Digital Transformation Evaluation
Lot-3	Academic, Curriculum, Assessment & Capacity Building Evaluation
Lot-4	Social Sector Programmes, Scholarships, Literacy, TVET & Skills Evaluation
Lot-5	Institutional Performance, Governance & Higher Education Evaluation
Lot-6	Research, Innovation, Policy, Funding Utilisation & Value-for-Money Evaluation

Detailed eligibility criteria, evaluation methodology, Lot-specific requirements, scope of services and application procedures are provided in the EOI / Prequalification Document which can be downloaded from PPRA e-PADS, the PPRA website (www.ppra.org.pk) and the Ministry's website (www.mofept.gov.pk). Interested firms shall submit their proposal through PPRA e-PADS, along with one (01) original hard copy in a sealed envelope addressed to the office of the undersigned, so as to reach on or before **August 20, 2026 by 02:00 p.m.** The EOIs shall be opened on the same day at **02:30 p.m.** in the presence of the representatives of the applicant firms who choose to attend. EOIs received after the prescribed date and time shall not be entertained.

The Ministry reserves the right to accept or reject any or all EOIs, or to annul the prequalification process at any stage, in accordance with the Public Procurement Rules, 2004, without assigning any reason.
