6. Manual submission of Bids shall not be entertained. Bidder are required to submit their E-Bids on or before **Monday, July 20, 2026 10:00AM**. E-Bids will be opened using E-PADS V.2.0 on the same day at **Monday, July 20, 2026 10:30AM**.
7. **Pre-Bid Meeting will be held on Monday, July 13, 2026 10:00AM** at Room No. 311, MM Directorate, PESCO Headquarters, Shami Road, Peshawar.

9. In terms of Rules 48 of Public Procurement Rules, 2004 Grievance Redressal Committee (GRC) is notified for the subject procurement and available of E-PADS v2.0.
10. The bids having Conditional bids, partial, incomplete documents and not submitted the Sealed Original CDR/Bank Guarantee as Bid Security shall be rejected.
