7. Manual submission of Bids shall not be entertained. Bidder are required to submit their E-Bids on or before **Friday, August 28, 2026 10:00AM**. E-Bids will be opened using E-PADS V.2.0 on the same day at **Friday, August 28, 2026 10:30AM**.
