The Ministry of Human Rights, Islamabad has reserved funds under its procurement plan for FY 2026–27 and intends to utilize part of these funds for eligible payments under the contract for consultancy services for “**ISO 9001:2015 Quality Management System (QMS) Audit and Certification**”, Reference No. **P135624**. The Ministry of Human Rights, Islamabad invites **Request for Proposals (RFPs)** through **EPADS v2.0** from eligible Consultants/Firms registered on EPADS v2.0 for provision of the said consultancy services.

The procurement shall be carried out through **Open Competitive Bidding** by adopting the **Single Stage–Two Envelope Procedure** and **Quality and Cost Based Selection (QCBS)** technique, in accordance with the **Public Procurement Rules, 2004**, applicable PPRA Regulations, the National Request for Proposal Document for Consultancy Services, and instructions issued by PPRA from time to time. The proposal shall be accompanied by the required **Bid Security**, as specified in the Bid Security Section of the RFP/Bidding Documents, in the prescribed form, including **Pay Order, Banker's Cheque or Bid Securing Declaration**, as applicable.

Complete e-Bidding/RFP Documents containing detailed Terms of Reference, eligibility and qualification requirements, evaluation criteria, terms and conditions, forms and other requirements are available through EPADS v2.0 at <https://epads.gov.pk/opportunities/federal/procurements/135624>. Proposals prepared in accordance with the RFP/e-Bidding Documents shall be submitted **electronically through EPADS v2.0** on or before **Monday, 12 October 2026 at 11:00 AM**. **Manual submission of proposals shall not be entertained.**

The proposals shall be opened **electronically through EPADS v2.0** on **Monday, 12 October 2026 at 12:30 PM** in the **Conference Room, Ministry of Human Rights, 9th Floor, Kohsar Block, New Pak Secretariat, Sector F-5, Constitution Avenue, Islamabad**, in the presence of bidders or their authorized representatives who may choose to attend. The opening shall be conducted in accordance with the applicable provisions of the Public Procurement Rules, 2004 and the RFP/Bidding Documents.
