- iv. All proposals/ bid accompanied by a Bid Security amount tabulated above against each purchase, in shape of pay-order issued in favor of DDO SPHQ, IBD, Karachi. Hard copy of proposal/ bid document alongwith original bid security pay order must reach at the office **on or before 17.08.2026 at 12:00 PM**. Scanned copy of the pay-order must be uploaded on EPADS.
