Bidding will be conducted pursuant to ‘**Single-Stage One Envelope procedure**’ under **Rule 36(a) of Public Procurement Rules (PPR), 2004**.

2. The e-bidding documents, in accordance with relevant regulations and containing detailed terms, conditions, specifications, and requirements, are available to registered bidders on EPADS 2.0 at <https://vendors.epads.gov.pk/login>
3. All electronic Bids must be accompanied by a Bid Security i.e., as specified in the table above, in the form of Demand Draft / Pay Order / Bank Guarantee made payable to “**Financial Monitoring Unit Government of Pakistan**”. The prospective bidders are required to upload scanned copy of Bid Security on EPADS 2.0.
4. Original bid security must be submitted to the procuring agency on or before the closing time of bid submission failing which the bid shall be rejected.
5. The electronic bids must be submitted through EPADS 2.0, along with a physical copy of the Original Bid Security in a sealed envelope at the office address given below) on or before the deadlines specified in the table. Manual submissions of Bids will **not be accepted**. The electronic Bids will be publicly opened via EPADS 2.0 on the same day, as per schedule mentioned in the table, at FMU Office, 2nd Floor, Main Building State Bank of Pakistan, I.I. Chundrigar Road Karachi. In case the bid opening date falls on a public holiday, the bids will be opened on the next working day at the same time and venue.
